Advisor's Guide for Giving

Gifts from Wills and Trusts:

When making a charitable gift to a nonprofit organization, it is vital the legal name of the charity, city and other identifying details be used. To name Cedar Hills UCC in your will or trust please use the following suggested language:

Residual Bequest - A residual bequest comes to us after your estate expenses and specific bequests are paid.

I give and devise to Cedar Hills United Church of Christ - Endowment Trust (Tax ID #13-1957221 – group exemption number 1665), located in Portland, OR, all (or state a percentage) of the rest, residue, and remainder of my estate, both real and personal, to be used for its general support (or for the support of a specific fund or program).

Specific Bequest - Naming Cedar Hills UCC as a beneficiary of a specific amount from your estate is easy.

I give and devise to Cedar Hills United Church of Christ - Endowment Trust (Tax ID # 13-1957221 – group exemption number 1665), located in Portland, OR, the sum of \$_____(or asset) to be used for its general support (or for the support of a specific fund or program).
